All totals represent individuals rather than households.								
Notes on Specific Methodology:								
#SNAP Customers with Disabilities: Individuals receiving SNAP benefits are considered disabled if they receive specific disability-related payments, such as Supplemental Security Income (SSI), Social Security Disability Insurance (SSDI), Veterans Affairs (VA) benefits, or similar programs. Those who do not receive these payments may still be recognized as disabled if they provide appropriate medical documentation verifying their condition.								
#SNAP Customers 18-64in Households where all children are 14-17: All adults 18-64 in SNAP households with children 14-17.								
#SNAP Customers 55-64 without dependent children: All individuals aged 55-64 who received SNAP. Households with children aged 0-17 are excluded.								
#SNAP Customers who are homeless: Individuals receiving SNAP benefits are considered homeless if the person does not have a fixed regular nighttime residence or the primary nighttime residence is a temporary accommodation (i.e. shelter, residence of another person, halfway house, etc.).								
The "Unknown" row (below Worcester County) includes individuals who do not have a fixed address of record, or have moved and not updated their address.								
Additional Specialty Population Data Notes:								
Veterans: We do not have complete information on the number of veterans receiving SNAP benefits. Although our current analysis shows 1,419 Marylanders who receive SNAP benefits and who reported veteran benefits as a source of income on their SNAP application, we know that this is a subset of the likely total.								
SNAP Heat & Eat: We continue to refine a local jurisdictional breakdown of these customers and anticipate completing this analysis by 8/8/2025.								
Notes on # of Youth who aged out of care in Maryland and are now between Ages 18-24:								
These totals reflect individuals who aged out of out-of-home care (foster care) in Maryland, and are currently over age 18 and under age 24 (as of July 14, 2025). The totals are based on data about exits from care January 1, 2020 to June 30, 2025. Data points with values below 10 are suppressed, as indicated by an asterisk (*).								
1. The data does not include individuals who were in foster care in another state or U.S. territory.								
2. Some individuals in the dataset may have since relocated out of state.								
3. Some individuals in the dataset may now be parents themselves and could be exempt from SNAP work requirements due to having dependents under the age of 14.								
4. The jurisdiction reflects where the youth aged out of care, not necessarily where they currently reside.								
5. Not all of these individuals may be receiving SNAP benefits.
