Beth Morrow emphasized child care as a vital public good, discussing efforts like Maryland's GO FCC initiative to expand family child care and remove local restrictions to increase access. She also highlighted affordability challenges, including rising costs and scholarship waitlists, and their impact on families' stability and well-being.
