2025 Legislative Session

The Maryland Commission for Women advocates in support of legislation that advances women's rights and creates opportunity for women's economic empowerment. Our final legislative agenda will be available in February. If you or your organization are working on legislation that fits within our policy agenda, and you would like the Commission to consider supporting your work, please email our Executive Director at Ariana. In addition to supporting select legislation, we will be tracking the progress of all legislation related to women's rights, and reporting on this at the end of Maryland's legislative session.

The Maryland Commission for Women also works in coalition with established women's rights organizations working on policy in Maryland, including the Maryland Network Against Domestic Violence (MNDAV), the Maryland Coalition Against Sexual Assault (MCASA), and the Maryland Legislative Agenda for Women (MLAW).

MCASA has released their 2025 legislative agenda. Key priorities include ensuring funding for rape crisis centers, expanding legal protections, and promoting education to prevent sexual violence.

MLAW has released their 2025 agenda, and will present it at an online event on Wednesday, February 5 at 5:00 p.m. The agenda includes supporting the Abortion Care Access Fund Act of 2025 and the Universal Newborn Nurse Visiting Services bill.

New Report Highlights Financial Challenges Facing Older Women

The U.S. Department of Labor's Women's Bureau has released a groundbreaking report, "Older Women's Wealth: The Impact of Work, Family, and Policy in the United States". This comprehensive study sheds light on the economic disparities older women face due to lifelong caregiving responsibilities, workforce interruptions, and systemic inequalities. A new movie celebrates a poignant tribute to the women of the historic 6888th Central Postal Directory Battalion, an all-Black, all-female unit from World War II, known as the "Six Triple Eight." Anne Arundel Commission for Women Celebrates 50 Years of Service

The Anne Arundel County Commission for Women (AACCW) celebrates 50 years of service to Anne Arundel County in 2025. Initially established in 1975 to serve as a resource and advocacy group for women of the County and to advise the County Executive on issues of

significance to women.

After conducting meetings and business virtually the previous three years, the Commission prioritized increasing awareness and engagement with the community by partnering with key County Offices and non-profits. Through partnership with Anne Arundel Workforce Development Corporation Career Coaches, AACCW expanded the reach of its "Journey to Success" Career Panels to reach over 500 middle school students in the County. The Career Panels bring together successful women from the community with middle and high school girls to provide career exploration and life lessons through personal stories of challenges and successes. To inform County residents during the election year, AACCW hosted "Women Who Vote" Forum featuring a panel of local candidates discussing topics of relevance to women as well as registered new voters.

The Commissioners were recognized at County Executive Civic Engagement Awards in December. Chair, Carolyn Keaton Culp, received the County Executive's Outstanding Steward Award which recognizes a Board/Commission Chair who has demonstrated outstanding leadership and consist stewardship of public resources while advocating for community needs. Two other Commissioners, Amanda Horne and Samantha Nagy were nominated for Outstanding Volunteer Award which recognizes individuals who strengthened the board/commission's ability to fulfill its mission or planned an initiative that resulted in a tangible positive impact on County residents.

In July 2024, Anne Arundel County Executive Steuart Pittman signed a new Executive Order re-affirming the County's commitment to this significant mission and increasing the commission to 19 members. In addition to formulating a budget proposal, the AACCW will publish the 2025 Strategic Action Plan which builds upon previous commission initiatives which made a successful impact on the community last year.
