# **Kinship Care Fact Sheet**

If you provide care for a relative's child for 24 hours day, seven days a week-there are benefits that you may be eligible to receive.













In Maryland, a person assuming care of a relative's child is referred to as Kinship Care.

As the relative caregiver, you are able to apply for certain benefits on behalf of the child(ren) in your care.

# **Temporary Cash Assistance (TCA)**

Provision provides cash assistance to eligible children and their relative caregivers. Legal custody is not required.

## Food Supplemental Program (FSP)

Food assistance based on income for the entire household.

#### **Child Care Scholarship Program (CCS)**

Provision provides financial assistance with child care costs to eligible Maryland families. Caregivers may qualify for a child care subsidy if they meet income and program requirements.

## **Maryland Children's Health Program (MCHP)**

MCHP provides full health benefits for higher income uninsured children (up to age 19 years). MCHP enrollees obtain care from a variety of Managed Care Organizations (MCOs) through the Maryland HealthChoice Program.

# **Medicaid-Medical Assistance (MA)**

State program that provides health coverage for individuals seeking coverage on the basis of being aged, blind, disabled, living in a nursing home, or medically needy.

### **Social Security Benefits**

If the parent(s) of the child in your care, is/are deceased or disabled, the child may be eligible for Survivor Benefits or Supplemental Security Income (SSI). You must apply directly with the Social Security Administration.

# **Consent for Health Care - Affidavit**

Provision provides for a relative of a child providing informal kinship care to consent to health care on behalf of the child. The relative must be able to verify the informal kinship care arrangement through an affidavit. To receive this form,

#### **School Enrollment-Informal Kinship Care**

Provision allows for a child in an informal kinship care relationship based on the six family hardships to receive an appropriate education in the jurisdiction where the relative resides. The informal kinship care arrangement must be verified through an affidavit.
