#### **Notice of Proposed Action**

The Secretary of Human Resources proposes to amend:

- (1) Regulation .02 under COMAR 07.02.07 Child Protective Services Investigation of Child Abuse and Neglect; and
- (2) Regulation .04 under COMAR 07.02.25 LDSS Foster Home Requirements.

#### **Statement of Purpose**

The purpose of this action is to amend regulations to reflect 2012 statutory amendments to Family Law Article, Annotated Code of Maryland, adding human sex trafficking to the definition of child sexual abuse, and making clear that the charge of human sex trafficking precludes foster parent certification.

## **Comparison to Federal Standards**

There is a corresponding federal standard to this proposed action, but the proposed action is not more restrictive or stringent.

#### **Estimate of Economic Impact**

The proposed action has no economic impact.

## **Economic Impact on Small Businesses**

The proposed action has minimal or no economic impact on small businesses.

## Impact on Individuals with Disabilities

The proposed action has no impact on individuals with disabilities.
