Children need healthy food year-round to play, grow, and learn. Maryland SUN Bucks helps families stretch their grocery budget during the summer when many children lose access to the free and reduced-price meals at school. To ensure children have access to healthy and nutritious meals, the Maryland SUN Bucks program provides \$40 per month for June, July and August (\$120 total) for each eligible child. Maryland SUN Bucks gives families the flexibility to choose foods that fit their culture and lifestyle.

While Maryland SUN Bucks is similar to the Summer SNAP program we offered from 2019 to 2023, our new program reaches far more children and provides larger benefits to families.

Eligibility

A school-aged child is eligible for benefits under the Maryland SUN Bucks program if they:

- Enrolled in a Maryland school that participates in Free and Reduced-Price School Meals (FARMS);
- Are age 5-18 and live in a household that participates in Supplemental Nutrition Assistance Program (SNAP), Temporary Cash Assistance (TCA), or Medical Assistance/Medicaid (MA);
- Applied for and were enrolled in FARMS or School Breakfast Program (SBP) during the 2023-2024 school year;
- Are in foster care, homeless, runaway, child of a migrant worker; or
- Do not meet the above criteria but apply and are determined eligible for FARMS by August 31, 2024.

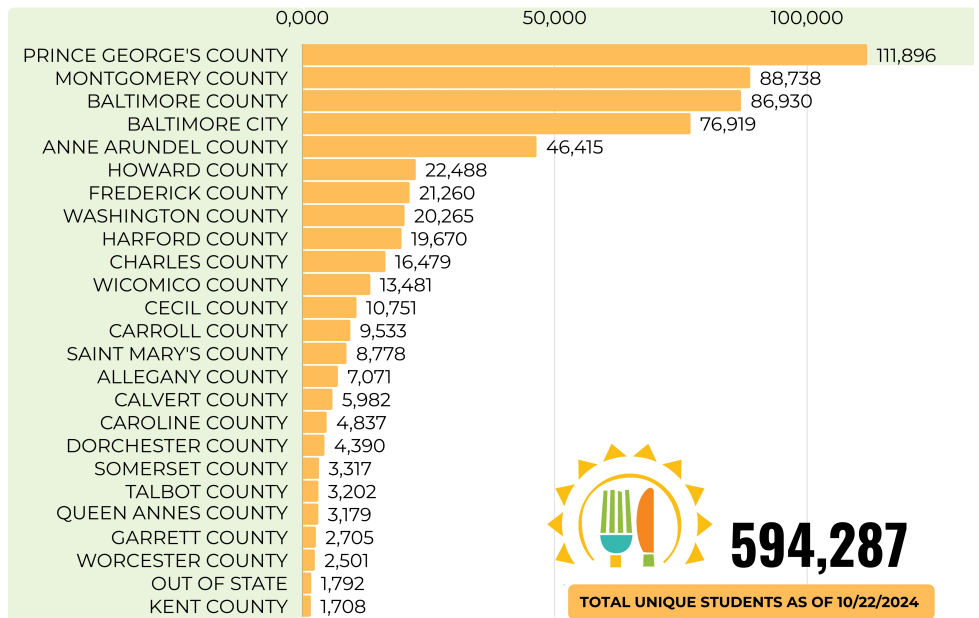
Enrollment

Most eligible children automatically received Maryland SUN Bucks if their household already participated in SNAP, TCA, or Medicaid or applied for and received Free and Reduced School Meals (FARMS) during the 2023-2024 school year. Children were also automatically enrolled if they were in out-of-home care, unhoused/homeless, migrant, or considered “runaway.”

No application was needed.

Children who were enrolled in a Community Eligibility Program (CEP) school that receives FARMS but were not on SNAP, TCA, or Medicaid, and did not fall into the previously mentioned categories, had to apply for the program. To be eligible for summer 2024, families had to apply by August 31, 2024.

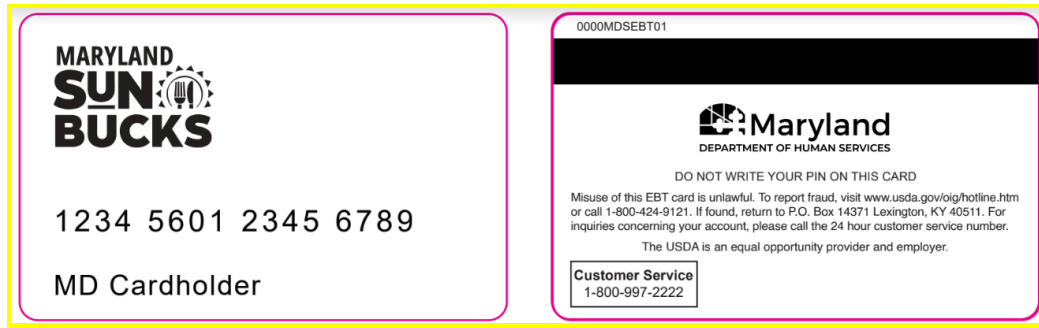
SUN BUCKS ISSUANCE BY JURISDICTION SUMMER 2024

How Maryland SUN Bucks Works

Maryland SUN Bucks benefits were issued on existing SNAP EBT cards for families who already received SNAP or TCA benefits. For children that did not receive SNAP or TCA benefits on an existing card, the benefits were issued on a new, white “Maryland SUN Bucks” card in the child’s name, pictured below.



The benefits can be used at authorized SNAP retailers, like grocery stores and farmers markets, to purchase healthy foods like fruits, vegetables, meats and other protein sources, whole grains, dairy, and other food products.
