Erin Easton -DHS- CSA: Good morning everyone. Thank you for taking time to join us today.

Erin Easton -DHS- CSA: Uh just to give a little background, um each year approximately \$10 million in federal mandatory grant funding is allocated to states and territories throughout the access and visitation program. This funding supports services that are designed to increase non-custodial parents access to their children, promote consistent and healthy parenting time, and reduce conflict between parties. According to the US Department of Health and Human Services, mediation and access and visitation disputes can lead to better outcomes for non-custodial parents. Specifically, when these disputes are mediated rather than litigated, non-custodial parents are more likely to remain involved in their children's lives, and more likely to comply with child support obligations. Mediation often helps to reduce conflict, encourages cooperation, and fosters agreements that both parents are more likely to follow, ultimately benefiting the children. While federal and state laws strictly enforce child support obligations, including both financial and medical, there is no equivalent nationwide mandate guaranteeing or enforcing a non-custodial parents visitation rights. In fact, child support is typically enforced through automated systems, wage garnishments, tax refund intercepts, and other legal tools.

Erin Easton -DHS- CSA: Visitation and custody, on the other hand, are generally treated as a civil matter. handled by state family courts and enforcement usually requires the custodial or non-custodial parent to go back to court if violation occurs. This imbalance can be frustrating for non-custodial parents who want to stay involved but face obstacles to visitation. With that, I thank you again for your time.

The solicitation aims to increase parenting time for non-custodial parents and their children in the hope of increasing non-custodial parents' compliance with child support payments. Among the customers to be served are non-custodial parents, absent fathers, and parents of children who receive title 4 D funds.

The child support history is that since 1992, the Department of Human Services has provided comprehensive employment and support services to fathers who are at risk of forsaking their parental responsibilities. In fiscal year, I'm sorry, in federal fiscal year 2021, Maryland's child support program totaled 173 362 cases, approximately 86% which is 149,793 of which had child support orders. Of those with child support orders, 134,647 were in a rears. And of those in Aras, 94,189, approximately 70% made overdue payments. Merlin's access and visitation program services are supervised visitation, counseling, mediation, developing parenting plans, domestic violence services, visitation enforcement, and parent education.

Uh the mediation is a conflict resolution process offered at no cost to the Carl community that can be utilized for a variety of conflicts at any stage of a dispute. The types of mediation services offered included neighborhood, family, and interpersonal.

They serve the community daytime, evenings, weekends at any location. They give people a chance to speak, to be heard, and to hear each other. Assist people in developing long-term solutions that meet the needs of everyone involved. Uh the information is confidential, private, and n is private and non-judgmental. The state of Maryland is looking to broaden its access and visitation program by placing stronger emphasis on our safeguard domestic violence and remote mediation services. Uh we will provide a larger number of mediation services to include parenting plans, parent education services, neutral drop off and pickup services, and supervised visitation services to families. Under the previous grant, Maryland executed access and visitation programs in two regions.
