REQUESTING AGENCY REMARKS: A notice of the availability of the Maryland Legal Services Program Adult Legal Services Request for Proposals (RFP) was advertised on the DHR Website, eMarylandMarketplace.com, The Star Democrat, The Dorchester Star, The Record Observer, The Times Record, The Bay Times, The Afro-American Newspaper, The Frederick News-Post, and The Daily Record. Copies of the Adult RFP Notice of Intent to Solicit were mailed directly to approximately 255 Maryland attorneys and/or law firms. Eleven of the prospective contractors on the mailing list were MBEs.

A total of 37 proposals were received in response to the Adult RFP from a total of eight Offerors. Six of these Offerors were incumbent contractors. Offeror submissions represented the entire State of Maryland (comprised of 13 jurisdictions and three Regions). Offerors were permitted to submit proposals for more than one jurisdiction and/or Region. Fifteen of the 37 proposals submitted are being recommended for contract award. Four single offers were received from two incumbent contractors representing one of the 13 jurisdictions and the three Regions. Each single offer was considered reasonable and selected for contract award since ample time was given for submission of proposals. In two of the Regions (Upper and Lower Eastern Shore), the Evaluation Committee was unable to award contracts as the single bid Offeror was deemed not susceptible for contract award. The 15 awards represent a total of five Offerors, all of which are incumbent contractors.

The Lower and Upper Eastern Shores are currently being handled by the incumbents. On 1/3/2008 when the new contracts begin, the adult guardianship cases in these two jurisdictions will officially be transferred back to the Courts and redistributed to private counsel at the Court's discretion. Payment for services in these jurisdictions would be made through the Court Appointed Attorney Program (CAAP). No modifications or extension on the current contract will be requested, and the program does not plan to re-solicit at this time.

There is a 3% MBE subcontracting goal on the contracts; however, three of five Contractors are Maryland Certified MBEs. Therefore the overall MBE participation is estimated to be 51% based on the contract amounts.

The State of Maryland is statutorily mandated to provide legal representation to indigent adults in Adult Protective Services and Adult Public Guardianship Review Board Hearings statewide. The Maryland Legal Services Program (MLSP) was created for the purpose of ensuring quality and effective legal representation in the State's Circuit Courts to the alleged disabled clients who may have been victims of abuse and/or neglect and where the local Department of Social Services or Office on Aging is a party to the case. Contracted legal services providers for the MLSP are required to provide consistent representation to this extremely vulnerable population, and must serve as a voice for the alleged disabled client in various settings to ensure that indigent adults are safe, and that their legal rights are protected.

Contract awards were made by jurisdiction to the offerors deemed most advantageous to the State, with technical factors having greater weight than financial factors. The previous Adult legal services contracts awarded in 2001 were for a five-year period, and were extended several times to accommodate a lengthy procurement process. As such, the fully loaded fixed-unit price per case is reflective of increased costs in business, as well as growth in the total number of cases to be served over the three-year, six-month base period term. In addition, the price per case reflects a 3% annual increase in the projected caseload per jurisdiction. Incumbent Adult contractors have been performing satisfactorily up to the present date, and in some instances, at a seriously low rate of reimbursement for services rendered. For these reasons it is believed to be in the State's best interest to award these contracts.

Under the terms of the solicitation, the technical ranking had more weight in the overall award determination than did the financial ranking.
