#### **PURPOSE:**

This policy directive provides instruction for the utilization of short-term placements which may be utilized by local departments of social services case managers. The policy is intended to provide guidelines for the utilization of beds for short-term placement at Arrow Child and Family Ministries, The Children's Home, and Brook Lane's Stone Bridge. This policy directive outlines the procedures and admissions criteria that case managers are to follow during the admission and discharge of children to/from these short-term placements and is intended to serve youth who require a temporary (60 day) step-down placement from an acute psychiatric hospital and who are awaiting their recommended permanent appropriate placement, or youth who are at risk of being admitted to a psychiatric hospital as a diversion.

### **BACKGROUND:**

Short-term placements were developed to prevent youth who are awaiting their recommended placement from remaining at a psychiatric hospital beyond the established discharge date who are awaiting their recommended placement; to serve youth to prevent an acute psychiatric hospitalization; or as a diversion for youth who are at risk of being admitted to a psychiatric hospital as a diversion.

### Authority:

- Human Services Article, MD. Ann. Code §§ 4-204 and 4-205;
- COMAR 14.31.03;
- COMAR 14.31.05; and
- The Lisa L. settlement agreement

### **DEFINITIONS:**

In this policy, the following terms have the meanings indicated.

- Short-term placement refers to a setting used to provide services to youth who require a short term (60 day) step down placement from an acute psychiatric hospital and who are awaiting their recommended permanent placement; intended as a diversion for youth who are in danger of being admitted to a psychiatric hospital; or for youth who are pending a more restrictive level of care/placement, i.e., an RTC.
- RTC means Residential Treatment Center.

#### IMPLEMENTATION:

Local department staff is required to send an email notification to the Placement Services and Inter-Agency Initiatives Office at SSA to place a youth in a bed for a short-term placement at Arrow Child and Family Ministries, The Children's Home, and Brook Lane's Stone Bridge. Upon SSA notification, the local department may proceed with the placement process. In an extreme emergency, the local department may place the youth prior to notifying SSA. Short-term placements are designed to offer a temporary stay (60 day) pending the availability of a recommended placement. If a child in DHR's custody is recommended for an RTC, the local department is expected to make every reasonable effort to place the child in an RTC directly from the hospital to circumvent the need for an interim placement.

# MAIL ADMISSIONS AND DISCHARGE NOTIFICATION FROM THE LOCAL DEPARTMENT:

#### ADMISSION:

- Send an email notification/confirmation to Placement Services and Inter-Agency Initiatives Office at SSA within 24 hours of a youth's admission to the Short-Term Placement.
- Update the placement in CHESSIE within 24 hours of a youth's admission to Arrow Child and Family Ministries, The Children's Home, or Brook Lane's Stone Bridge.

### DISCHARGES:

- Send an email notification to Placement Services and Inter-Agency Initiatives Office at SSA within 24 hours of a youth's discharge from the Short-term placement.
- Update the placement in CHESSIE within 24 hours of a youth's discharge from the Short-term placement.

### LENGTH OF STAY:

- The maximum length of stay in the short-term placement at Arrow Child and Family Ministries, The Children's Home, and Brook Lane's Stone Bridge is not to exceed 60-calendar days.
- If a child requires a stay beyond 60 calendar days, the Case Manager must complete and fax (#410-333-0127) a Request for Extension, Short-Term Placement form to SSA by the 55<sup>th</sup> calendar day.

In addition, if a child stays in a short-term placement beyond the 60 calendar days, the case manager must provide a written summary, detailing the progress to place the youth, to SSA via email every 20 days thereafter.
